FIELD NOTES FOR A 10.749 ACRE TRACT (CALLED 10.752 ACRES - VOLUME 316, PAGE 913) BEING ALL OF THAT CERTAIN 6.450 ACRE TRACT (LOT 3) AND PART OF THAT CERTAIN 6.454 ACRE TRACT (LOT 4), SAID LOTS BEING A PART OF PINERIDGE SUBDIVISION, SECTION 5 (VOLUME 297, PAGE 596, DEED RECORDS), LOCATED IN THE GEORGE A. DENNETT SURVEY, ABSTRACT 123, WALLER COUNTY, TEXAS; SAID 10.749 ACRE TRACT BEING MORE SPECIFICALLY DESCRIBED AS FOLLOWS:

BEGINNING: At a 1/2 inch Iron rod set in the center of a 30 foot right-of-way easement for the West corner of this 10.749 acre tract, same being the West corner of Lot 3 and the South corner of a 6.450 acre tract (Lot 2);

THENCE: North 18° 15' 12" East along the Southeast line of Lot 2, along the Northwest line of Lot 3, and along the Northwest line of this 10.749 acre tract, a distance of 430.40 feet to a 3/8 inch Iron rod found for the East corner of Lot 2, for the North corner of Lot 3, and for the North corner of this 10.749 acre tract;

THENCE: South 72° 16' 06" East along the Northeast line of this 10.749 acre tract a distance of 450.89 feet to a 1/2 inch iron rod set at an angle point;

THENCE: South 71° 58' 53" East along the Northeast line of this 10.749 acre tract, at a distance of 202.83 feet pass the East corner of Lot 3 and the North corner of Lot 4, and continuing an additional distance of 438.87 feet for a total distance of 641.70 feet to a 1/2 inch iron rod set for the East corner of this 10.749 acre tract;

THENCE: South 18° 22' 31" West along the Southeast line of this 10.749 acre tract a distance of 425.75 feet to a 1/2 inch iron rod set in the centerline of a 30 foot right-of-way easement for the South corner of this 10.749 acre tract;

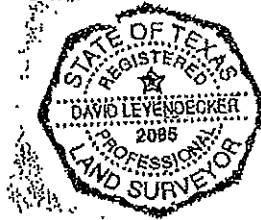
THENCE: North 72° 20' 40" West along the Southwest line of this 10.749 acre tract and along the centerline of said right-of-way easement, at a distance of 438.88 feet pass the South corner of Lot 3 and the West corner of Lot 4, and continuing an additional distance of 652.84 feet for a total distance of 1091.72 feet to the **ACTUAL PLACE OF BEGINNING** and containing 10.749 acres of land.

All bearings recited herein are based on the Northeast line of this 10.749 acre tract running South 71° 58' 53" East.
