## SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SADDLE CREEK FOREST

THIS SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SADDLE CREEK FOREST is made as of the date stated below, by BLUEGREEN SOUTHWEST ONE, L.P., a Delaware limited partnership (hereinafter referred to as "Declarant") and replaces those portions and paragraphs as stated in Master Restrictions filed of record at Volume 910, Pages 135 – 185, Official Real Property Records of Waller County, Texas, at Volume 1138, Pages 564-615, Official Real Property Records of Grimes County, Texas.

#### WITNESSETH:

WHEREAS, Declarant prepared and filed of record that certain Declaration of Covenants, Conditions and Restrictions for Saddle Creek Forest, at Volume 910, Pages 135 - 185, Official Real Property Records of Waller County, Texas, at Volume 1138, Pages 564-615, Official Real Property Records of Grimes County, Texas (herein referred to as the "Master Declaration"); and

WHEREAS, Declarant prepared and filed of record that certain First Amendment to Declaration of Covenants, Conditions and Restrictions for SADDLE CREEK FOREST filed on September 4, 2007, at Volume 1063, Page 587-592 and under Clerk's Document #707833, Official Real Property Records of Waller County, Texas and on September 19, 2007 at Volume 1236, Page 778-782 and under Clerk's Document #217952, Official Real Property Records of Grimes County, Texas.

WHEREAS, Declarant prepared and filed of record that certain Supplemental Declarations of Covenants, Conditions and Restrictions for SADDLE CREEK FOREST, Section One, were filed at Volume 910, Pages 186–189, Official Real Property Records of Waller County, Texas;

WHEREAS, Declarant may unilaterally amend the Master Declaration in accordance with Section 15.2(a) of the Master Declaration as it pertains to the real property described on Exhibit "A" attached hereto for any reason; and

WHEREAS, the Class B membership has not yet terminated, and therefore, Declarant has the authority to Amend the Master Declaration; and

WHEREAS, the Declarant desires to amend and restate some of the terms of the Master Declaration;

NOW, THEREFORE, pursuant to the powers retained by Declarant under the Master Declaration, Declarant hereby subjects the real property described on Exhibit "A" hereof to the provisions of the Master Declaration and the Supplemental Declarations, which shall apply to such property in addition to the provisions of the Master Declaration. Such property shall be sold, transferred, used, conveyed, occupied, and mortgaged or otherwise encumbered pursuant to the provisions of the Supplemental Declarations and the Master Declaration, both of which shall run with the title to such property and shall be binding upon all persons having any right, title, or any interest in such property, their respective heirs, legal representatives, successors, successors' in title and assigns. The provisions of the Supplemental Declaration.

### ARTICLE 1 Definitions

The definitions set forth in Article 1 of the Master Declaration are hereby incorporated by reference, unless said terms are otherwise defined herein.

## ARTICLE 2 Maintenance

In addition to the Maintenance requirements set forth in Article 5 of the Master Declaration, the following shall apply to Saddle Creek Forest development:

The Association's Responsibility.

The Association shall maintain and keep in good condition, order and repair the Area of Common Responsibility, which shall include, but need not be limited to:

such portions of any additional property included within the Area of Common Responsibility as may be dictated by this Master Declaration, any Supplemental

Declaration, Agreement, or any contract or agreement for maintenance thereof entered into by the Association;

#### ARTICLE 3 Assessments

Article 8.1 of the Master Declaration is hereby supplemented to add the following paragraph into the Master Declaration. This paragraph shall be added to the Master Declaration and shall be in full force and effect notwithstanding anything stated in the Master Declaration to the contrary.

The Board of Directors Ability to Increase or Decrease Annual Assessments. Saddle Creek Forest and all neighborhoods thereto shall be subject to the Annual Assessment for the benefit and use within the Saddle Creek Forest development or the specific Neighborhood designated by the Board of Directors only. The Annual Assessment may be amended and modified by the Association as needed or required in the future without the need for a vote from the members of the Saddle Creek Forest development, but in no event may the Annual Assessment specific to The Saddle Creek Forest Development be increased by more than ten percent (10%) per year, and such Annual Assessment may only be increased by ten percent (10%) no more than three (3) consecutive years. If the Annual Assessment has been increased by the Board for three (3) consecutive years, any further increases in the Annual Assessment for the fourth (4th) year must be voted on by the entire Saddle Creek Forest development and approved as stated in the Declaration and Bylaws; however, if after three (3) consecutive years, the Board has increased the Annual Assessment pursuant to this provision, and do not raise or lower the Annual Assessment in the fourth year, then the Board may, at its discretion, raise or lower the Annual Assessment in their discretion and start the three (3) year process again. Any proposed increase or decrease in the Assessment by the Association of greater than 10% per year must be voted on pursuant to the Declaration and the Bylaws, and cannot be done by Board action alone.

## ARTICLE 4 Declaration

Except as specifically amended hereby, the Master Declaration and all terms thereof shall remain in full force and effect.
